



# Good Spirit Bible Camp

## Paintball Waiver and Release of Liability

In consideration of being allowed to participate in any way in the Good Spirit Bible Camp paintball program, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury and illness (ex: communicable diseases such as MRA, influenza, and COVID-19) from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist; and
2. **I knowingly and freely assume all such risks**, both known and unknown, **even if arising from the negligence of the releasees** or others, and assume full responsibility for my participation; and
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and
4. In consideration of the payment of \$1.00 and other valuable consideration, I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **hereby release and hold harmless Good Spirit Bible Camp and the Saskatchewan Baptist Association**, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event (“Releases”), **with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releasees or otherwise**; and
5. I, the parent/guardian of the minor named below, authorize the leaders of Good Spirit Bible Camp to sign a consent for medical treatment and to authorize any physician or hospital to provide medical assessment treatment or procedures for the minor named below.
6. I willingly agree to comply with health and safety measures including practicing physical distancing, proper hygiene, and sanitation (such as hand washing/sanitizing upon arrival and departure) and following the COVID-19 signage posted at the camp.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
